One hundred and seventy years ago, Ireland was in the the second year of blight that destroyed the principle means of sustenance for the Irish people, the potato. The year 1847 was to go down in infamy as the worst year of the great hunger and earn the

title "Black '47", Hundreds of emigrants arriving in the ports of the United States gave personal testimony of the horrors being experienced in Ireland that were often lacking in British newspapers and America was moved to act. The great orator Henry Clay stated before the U.S. Senate 'No imagination can conceive —no tongue express—no brush paint—the horrors of the scenes which are daily exhibited in Ireland'. Yet, several attempts at passing a famine relief bill for Ireland failed. Ironically, Clay had lost the presidency to current President Polk who had been substantially supported by the New York Democratic machine turning out the vote amongst thousands of recently arrived Irish immigrants; yet Polk made it clear he would veto any Irish relief legislation that required an expenditure of U.S. funds for charity on the basis of constitutionality. Other opposition was less pedantic and was rooted in anti-Irish prejudice and fears of "embarrassing" England; better that the Irish should starve than Britain blush.

While the Congress and President Polk blocked the passage of a U.S. government relief bill, Senator John Fairfield of Maine arrived at a solution to break the impasse and provide some American relief to Ireland. The Senator proposed the "loan" of two Navy Frigates, the Jamestown and the Macedonia, for the use by private relief efforts. The ships would be commanded by two experienced merchant mariners, Robert Forbes of Boston and George DeKay of New Jersey. Since this only involved "the use" of government property it avoided any objections on constitutional grounds and was passed.

The Jamestown's captain Robert Forbes was one of the most successful mariners in Boston; he had gone to sea at the age of 13 and made a fortune in the China trade. Forbes quickly embraced the mission of Irish relief with the same zeal; he recalled the relief that Ireland had sent the Massachusetts colony shortly after the devastation wrought by King Phillip's War in 1676. Forbes wrote "The amount of the contributions of Irishmen in 1676, if calculated at compound interest, would amount to a sum so large that I dare not say how much we should still be indebted... we have "cast our bread upon the waters" partly for the payment of an old debt and partly to plant in Irish hearts a debt which will, in future days, come back to us bearing fruit crowed with peace and good will"

Appropriately, on March 17th 1847 the process of loading the Jamestown, her guns now removed, began. Over the course of only three weeks, a relief committee chaired by Boston Mayor Josiah Quincy raised more than \$150,000 from donors stretching from Arkansas to Maine including \$170 from the Choctaw Indian nation. The government suspended tolls for any aid transport and the railroads shipped relief supplies marked IRELAND for free. Dozens of seamen volunteered for service in response to ads that

were run complimentary by newspapers. On March 28th, the Jamestown left Boston harbor on its mission of mercy with more than 8,000 barrels of bread, beans, pork, peas, corn, flour, rice, beef, potatoes and other supplies.

Under Forbes command, the Jamestown made swift passage to Ireland, taking only 15 days to reach Cobh harbor where it was greeted with cheering crowds and a band playing "Yankee Doodle". Work quickly began on distribution the Jamestown's cargo to 150 relief locations throughout Cork. Sadly, Cork's gentry readily demonstrated how disconnected they and their government were from the plight of the Irish people by throwing banquets for Forbes and his crew where toasts to the Royal Family were frequent. However, Fr. Theobold Matthew, who would gain acclaim for his temperance movement, ensured that Captain Forbes would see and take back to America the true picture of Ireland's plight. Fr. Matthew took Forbes on a tour of the city just a short distance from the grand homes of the ascendancy. Forbes describe what he saw as "The valley of death and pestilence itself ... I saw enough in five minutes to horrify me."

Forbes sailed for Boston and returned the Jamestown to the U.S. after its brief, but successful 49 day voyage. Progress on the relief ship Macedonia in New York had not gone as smoothly. New York of the 1840's was the center of the anti-Irish nativist movement who worked to blocked the humanitarian mission of the Macedonia at every opportunity. Forbes would bring his dedication and energy to the assistance of Captain DeKay and the Macedonia finally departed New York with its much-needed cargo of food, though Captain DeKay would later be financially ruined because of the large sums of money he personally put forward to see the noble mission of the voyage through.

As successful as one of America's first international relief effort was, it could only put a small dent in the unimaginable suffering of the Great Hunger in Ireland that resulted in over one million deaths in a country of eight million. While America and other nations were sending food to Ireland, British policy was still exporting local produce away from starving Ireland. In the same year of 1847 that the U.S. Jamestown and Macedonia were delivering aid, Guinness exported nearly 300,000 gallons of stout to Britain using locally produced grain that could have helped feed the starving of Ireland. The capacity for self-deception to justify British irresponsibility for the starvation In Ireland is typified by a London Times editorial reacting to the Jamestown relief effort "We will confess to a passing sensation of wounded pride when we hear of our fellow subjects (the Irish) becoming objects of republican (U.S.) benevolence, and our social sores being exposed in the cities of New England. But if we are unable to rescue Ireland from the grasp of famine, as confessedly we are, it does not become us to resent the assistance of a generous kinsman and friend. Whoever is to blame, most true it is that Ireland does not prosper in our hands." Like many in London, the Times was more concerned with English pride than Irish lives. One hundred and seventy years on, it is still "most true it is that Ireland does not prosper in (British) hands". The British government continues to stall on the pursuit of justice for the victims of legacy issue and the recent British decision on Brexit threatens the very foundations of the Good Friday agreement. If a lasting peace is to be achieved in Ireland, then the U.S. must channel the spirit of the Jamestown and Macedonia relief missions and reengage in Northern Ireland to demand the promises of the Good Friday Agreement it help negotiate be fulfilled.




