## The Great Hunger, There was Nothing Funny About It

We live in an age where what was once unimaginable is daily becoming reality. Unfortunately, this is not always a positive development. A case in point is the announcement on New Year's day that British Channel 4 has among its plans for the year to develop a new "comedy series" called "*Hungry*" based in the time and around the event of Ireland's Great Hunger (*An Gorta Mor*) often (including Channel 4's press release and subsequent news coverage) inaccurately call the Irish Famine. As Irish American, many of whom can trace their heritage to the displaced refugees of one of the greatest acts of tragedy and cruelty in the history of man should be outraged. Sadly, in reading some of the defenses made by Channel 4 and its proponents it becomes glaringly obvious how little is known of Ireland's holocaust.

The basic facts are clear and unequivocal. On 13 September 1845, the *Gardner's Chronicle* announced "*We stop the Press with very great regret to announce that the potato Murrain (blight) has unequivocally declared itself in Ireland.*" That single sentence ushered in a period of seven years of unparalleled human tragedy where at **minimum** over one million people died, a disproportionate number being children, and another million were forced into exile. Death by starvation and the disease that accompanies it is slow and agonizing process and is suffocating in the dark, fetid holds of the "Coffin Ships" that transported the evicted. There is certainly no humor about it.

The appearance of the blight was hardly a surprise and its dire consequences for Ireland anticipated. The blight had first been seen (ironically) in England, Belgium, Holland and France. The impact that the blight taking hold in Ireland should also not have been a surprise; since the British Parliament had taken direct control of Ireland through the 1801 Act of Union, no less that 150 commissions and committee had reported on the precarious state that English rule had reduced Ireland to. The Penal Laws and the greed of absentee landlords who had no affinity with their tenants had pushed Irish families onto progressively smaller plots of land of decreasing quality; good land was reserved for the grazing of cattle and the

production of produce for export to England. The only crop that could be grown on the land available to the general Irish population that could provide sufficient sustenance was the potato, which despite its poor reputation today provides when supplemented with some protein from a source such as milk all the necessary vitamin and nutrients to sustain a healthy person. There was little to no investment in Ireland, in fact when attempts were made to develop local industry such as linen production, the British Government was quick to levy tariffs on the Irish produced good in an attempt to undermine Irish industry in favor of English. British policy was clear: Ireland and her people, while allegedly members of a "United Kingdom", were resources to be exploited and nothing more.

While the same potato blight occurred in other countries, none of them suffered the cataclysm that befell Ireland; the reason being that their respective governments intervened and took measures to mitigate the suffering. In England the response was inept and halting. The first priority of the British Government was to ensure that the English economy was protected; that in the face of an unprecedented calamity that English business be unsullied. Prime Minister Peel stated after a year of starvation in Ireland '*There is such a tendency to exaggeration and inaccuracy in Irish reports that delay in acting on them is always desirable*'. How many lives were lost to Peel's desirable delay is incalculable and the question to if the British Government would find such a delay as "desirable" if people were starving in Devon as opposed to Galway a fair one. When the deaths and suffering became too great to ignore, British relief efforts were inadequate and halting; effective relief always taking a secondary precedent to isolating English business interest from the suffering of those whom the crown claimed were former British Citizens.

To justify a wholly inadequate response to millions starving, the equivalent of the 19<sup>th</sup> century British spin machine was initiated. Despite being part of the British Union, the problems in Ireland were an Irish problem. "Irish property must pay for Irish Poverty", despite that fact it was clear that this "Irish Property's mismanagement

has created the environment that gave rise to this humanitarian disaster. Now "Irish Property" in the form of absentee landlords, many of whom had likely never visited the estates whose rents in better days were supporting their lifestyle in England were now with, the flow of rents cutoff because their tenants were starving were expected to pay maintenance based on each tenant they had. The consequences were obvious: the landlords would evict their tenants rather than pay the rates increasing the human suffering. Through it all British Politicians showed an uncanny ability at delusion and self-justification. Numerous statements were made that "*This was after all a problem the Irish brought on themselves*", "*It was an act of Providence in response to Irish intemperate ways*", that the "*Irish are lazy*" which both justified not sending them aid as "*the Irish may become too dependent on it*" and that it would stunt the evolution of the Ireland to more productive farming methods. In its most grotesque form, a senior British advisor Nassau William Senior, the first professor of political economy at Oxford lamented "if only one million die in the Irish famine it would be too little to do much good"

These are the facts of the famine and there is not one funny one that would justify a comedic treatment of this horrific event in human, let alone Irish, history. The scars of the famine still run deep: 170 years later Ireland's population is still below pre-famine levels. Many of the negative stereotypes that denigrate our proud heritage today are the result of the British government attempts to justify allowing a minimum of one million people to starve to further their agenda; if this event occurred today, it would be regarded as ethnic cleansing. That someone would think any of this is a fit subject for comedy displays an ignorance of the facts or more abhorrently the same callous disregard of suffering in the pursuit of profit as exhibited by Nassau William Senior. Critics of Channel 4's critics claim that those who are objecting to a "famine comedy" are advocating censorship, to this I say no; censorship. Is a suppression of information. Channel 4 by this outrageous proposal is proof that we need the full story of the Great Hunger to be told, not a sanitized comedic one.

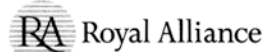
